
## Greetings Neighbors:

# SVCA December Quarterly Meeting – UW Urban Canid Project

The SVCA December 17 quarterly meeting drew a large crowd, including Midvale Heights residents, to hear guest speaker Dr. David Drake, UW Madison Dept. Forest & Wildlife Ecology, on the topic of Urban Foxes and Coyotes and his work with the UW Urban Canid Project (UWUCP). Dr. Drake gave an excellent and informative presentation. Among the highlights – foxes and coyotes are habitat generalists. They are omnivores that adapt well to both wilderness and urban settings. They eat deer, rabbits, mice, voles, berries, grass, nuts, tomatoes from our gardens and much more. Coyotes appear to be more tightly clustered in larger green spaces and natural areas, while foxes are wide ranging in highly residential/urban areas.

Areas of UWUCP study and their purpose include:


- Interspecific interaction: Foxes and coyotes are canines, and almost always the coyote will kill the fox. In the city this predator – prey dynamic is breaking down, possibly due to the abundance of food.
- Disease risk: to analyze what diseases are prevalent in the fox and coyote populations in Madison and to better understand risks to unvaccinated dogs, such as rabies and heartworm.
- Engage students and the public in the research, including efforts to prevent an outbreak of coyotes attacking dogs.




The study animals are trapped and treated very humanely. They are tested for diseases, tagged, and radio-collared in order to observe how they share space, and location. New tracking data indicate that foxes and coyotes can coexist. Future directions of research include population estimates, pup dispersal, and behavior. Dr. Drake said that they would like to do more fox trapping/tracking in the Sunset Village area.

To keep wildlife wild and safe it is suggested that we do not feed our pets outside, keep their vaccinations current, keep them on a leash or in an enclosed area and never unattended, and keep a safe distance when observing wildlife.

## Midtown Police Station Passes Council Unanimously

The Common Council addressed the Capital and Operating Budgets on Tuesday, November 10, with public testimony and lengthy deliberation. District 11 Ald. Chris Schmidt and nine other alders sponsored an amendment/alternative cost structure that will put off hiring for positions for the station until late 2017; that will delay the station’s operating cost until the 2018 budget. Construction will start in 2016 and the station will open in 2018.

To my constituents, colleagues, and friends,

I am hereby giving notice to the Common Council that I am resigning my seat as District 11 Alder effective January 31, 2016. It has been an honor and a privilege to serve as District 11 Alder for nearly seven years. Circumstances in my professional life have changed since I filed for re-election last fall, and my career in satellite meteorology requires my full attention. Serving the City as Alder, itself a full-time job, has been very important to me, but being Alder is not my livelihood, and my livelihood must come first.



# Hillcrest Drive Reconstruction

Hillcrest Drive from Midvale Blvd. to Westmorland Blvd., and Hillcrest Circle, will be under construction for four months, beginning mid-April. This project will include water main and sanitary sewer replacement, new storm sewer, street repaving, and addition of curb and gutter. Many Hillcrest residents braved a cold, rainy night at the end of November to attend the last Public Informational Meeting. The sentiment of this group of neighbors is overwhelmingly against curb and gutter, but it is the non-negotiable policy of the City to put in curb and gutter anytime a street is re-constructed. Some Hillcrest neighbors' concerns have been expressed in a letter by Hillcrest Drive resident, Albert Bryan, distributed at the September 9, 2015 SVCA quarterly meeting. Mr. Bryan listed these concerns also in testimony at the Common Council meeting on January 5, 2016. See the SVCA Facebook page for Albert Bryan's complete letter.

**Street construction** will replace all the pavement and gravel base; and install new curb and gutter. The proposed street width is 24 ft., which will allow for travel in both directions and parking on one side of the street. To preserve some large oak trees, the street will be narrowed to 21 ft. and have parking removed near the westerly intersection of Hillcrest Dr. & Circle and through 4325 Hillcrest Dr. The alignment of Hillcrest Dr. east of Owen Dr. will include some new bends in order to avoid existing trees and to provide some mild traffic calming.

**Regarding trees:** Efforts will be made to save as many of the existing trees as possible; however, there are several planned tree removals. Most are due to conflicts with the proposed street & sidewalk work, some are due to poor health/condition of the tree, and some are preemptive ash removals. Trees to be removed are: 201 Midvale (pine); 4322 Hillcrest (oak); 4302 Hillcrest (2 ash, buckthorn, hackberry); 205 Owen (oak); 4205 Hillcrest (ash); 4133 Hillcrest (elm); 4129 Hillcrest (silver maple); 125 Vaughn Ct (buckthorn, Norway maple); 4122 Hillcrest (oak); 4206 Hillcrest (oak). Kathy German says, "The beautiful oak on the Shirley's property [4325 Hillcrest] is being saved - whew!"

**Methods of tree protection** will include:

- Realignment/design of street
- Curb construction methods and instruction
- Bends & limits of work for sewer laterals
- Protective fencing around sensitive trees during construction

**Trenching machine & vibrations:** Kathy German reports, "They are going to be using a large piece of equipment to dig deep trenches in the middle of the street. This machine will cause significant vibrations. We were advised to take photos/videos of our home's interiors & exteriors in the chance that damage is done from the vibration. Concerns about damage would need to be addressed directly by the home owner to the contractor."

## Second Sunset Village Accessory Dwelling Unit

SVCA president Ken Raffa pointed out on the newsletter front page that Accessory Dwelling Units (ADUs) will continue to be an issue in Sunset Village. In a 10-24-2015 email to Alder Chris Schmidt, Anne Fuller (N. Meadow Lane) wrote, “When ‘alternate dwelling units’ were proposed to the Sunset Village Community Association (SVCA) we were led to believe that they would be unobtrusive and are meant for family members to be available if needed by the residents of the primary home of the property. Additionally, some of us felt that any of our efforts to protest these structures would be downplayed. In other words we had little choice in the matter.”

The ADU at 220 N. Meadow Lane came before the Plan Commission at its August 11, 2014 meeting and passed without comment or opposition from Sunset Village residents. Planning Division Staff, perhaps considering utility over aesthetics, examined the standard that, “*The uses, values, and enjoyment of other property in the neighborhood for purposes already established will not be substantially impaired or diminished in any foreseeable manner,*” and concluded that, “this standard can be met, as properties adjacent to the proposed structure have garages next to it. The property immediately adjacent to the north has a single-family home and an existing 575 square foot detached garage adjacent to the proposed garage/ADU. The property immediately adjacent to the west has a 4-unit building and a detached garage, directly behind the proposed garage/ADU.” This ADU has a new address, 222 N. Meadow Lane.

The ADU at 221 S. Midvale, proposed for completion by October 15, 2014, remains unfinished.



## Turn it on, Tune it in, Check it out: Neighborhood Radio 99.1 FM

WIDE-LP 99.1 FM is low power radio from our Midvale Heights neighbors. The 40-watt radio station began broadcasting from the Orchard Drive garage of Ken and Judy Skog in October 2015. It originated in 2008 in the garage of Bob Park on Hammersley Road. 99.1 FM broadcasts music and talk 24 hours a day. Programs include: Morning Mix, Story Classics at Noon, Freethought Radio, Science for the People, Indy Afternoon, After School Hour, Jim Hightower, Soft Comes the Night. The one program currently created by a resident of Midvale Heights, Steve Fitzsimmons, broadcasts crime alerts from the Midvale Heights Neighborhood Watch program.

The stated goal of WIDE-LP is “to provide a community resource that responds to the needs and interests of our listeners. We particularly focus on content that is not available via broadcasts from full power radio and TV stations in the area. We encourage area residents to create programs of their own that are attractive to their neighbors...Community input on programming will be sought through email from individuals and through our Radio Council. The Radio Council may solicit ideas from local neighborhood associations, local schools, the local Madison Common Council alder, etc.”

# Friends of Hoyt Park News



The city of Madison is going forward to place **Hoyt Park on the National Register of Historic Places**. It is already on the Madison Registry. John Elliott, Friends of Hoyt Park board member, wrote a letter on behalf of this organization supporting the National Register nomination of Hoyt Park. Amy Scanlon, preservation planner for the city of Madison, submitted a grant request for the nomination to the Historic Register; the process will take 1 to 2 years.

The **Friends of Hoyt Park Annual Meeting** will be Thursday, Apr 21 at 6:45 in the Fellowship Hall of Bethany United Methodist Church, 3910 Mineral Point Rd. The speaker will be graduate student, Marcus Mueller, who will tell us about the current UW study on urban foxes and coyotes in Madison. Marcus is working with Dr. David Drake, in the Department of Forestry and Wildlife Ecology, on the UW Urban Canid Project. This study began in January 2014, after coyotes were routinely seen on the western part of the UW-Madison campus and a family of red foxes was observed living under a campus building. Populations of foxes and coyotes have been monitored since then, and studies are being conducted on their territories, and interactions between the two species and with humans. This topic is particularly timely for the Hoyt Park area. Initial studies were conducted in the campus natural areas, Arboretum and general campus area into the Isthmus, downtown. They plan to expand active study to Hoyt Park and the surrounding neighborhoods this winter so we may hear about some very "local interest" stories! All members of the Friends of Hoyt Park, as well as those interested in joining, are welcome to attend. **Remember – Voter ID Needed for 2016 Elections**  
*Make sure you and the people you know are ready to vote*

Starting with the spring primary election on February 16th this year, most voters will need to show a photo ID at the polls. Acceptable forms of identification include:

- A WI driver's license (valid even if driving privileges have been revoked or suspended)
- A WI state ID card from the DOT
- A state ID card or driver's license without a photo issued under the religious exemption
- A military ID card issued by a U.S. uniformed service
- A U.S. passport

The address on your ID doesn't have to be current. The name on your ID doesn't need to be an exact match for your name in the poll book.

To obtain a state ID card from DOT, bring proof of name, date of birth, identity, citizenship, and WI residency to a DMV office. If you don't have a birth certificate, there is an alternate process to get a state ID. Call the DMV at (608) 266-1069 for more information.

UW – Madison student IDs are not valid photo IDs for voting. Any student who doesn't already have a WI driver's license or ID from DOT can obtain a separate voter ID card by bringing his or her existing Wiscard student ID to the Wiscard office in Union South.

If you haven't voted in Wisconsin before, or if you've moved since the last election, you will need to register to vote. You must have lived at your current address for 28 consecutive days before an election to vote from that address. If you've lived there fewer than 28 days, you can still vote from your old address.

You can register by mail up to 20 days before an election, at your municipal clerk's office through the Friday before an election, or at your polling place the day of an election. To register you will need:

A WI driver's license, state ID card, or the last four digits of your Social Security number  
Proof of residence, such as a property tax bill, utility bill, bank statement, paystub, residential lease, fishing or hunting license, vehicle registration, etc.  
A completed voter registration application, which is available at [www.gab.wi.gov](http://www.gab.wi.gov)

## Quarry Park Trail Usage Plan

The City of Madison Parks Division is developing a trail usage plan for Quarry Park, the 16 acres of woods and hills just east of Sunset Village. The City held its first Public Information Meeting on December 14, 2015. Quarry Park has long been a popular off-road biking destination, and when visitors request bike trails or places to bike the City has historically directed them there. Much of the bike trail building has been done by mountain biking groups, such as CORP (Capital Off Road Pathfinders), with little involvement from the City of Madison.

As reported at the meeting, a visit to the park from Eric Veum, the City of Madison's Risk Manager, was the basis for creating a usage plan—from a risk management perspective, the trails and biking activity are permitted, but he felt that a plan for conflict avoidance and possible separation of activities (pedestrian/dog-walking vs. biking) is needed. The preliminary draft plan limits walking trails to a fairly small area in the middle of the park, with the outer part designated for biking. This was not well received by the majority of attendees, especially walkers, who would like unrestricted access to the entire park. Many people pointed out that bikers and walkers have always gotten along fine, with minimal conflicts. More than one attendee described the designated walking area on the draft plan map as unattractive to walkers. City staff reassured walkers, garlic mustard pullers, etc., that no part of the park will be off limits, though there may be cautionary signage.

Parks staff gathered a list at the meeting of attendees willing to participate in a working group that will use input gathered from this meeting to further develop the trail usage plan concept. The working group will gather at a series of meetings in early 2016 to finalize a concept that will be presented to the neighborhood in spring 2016.


